RESOLUTION

Whereas, the Silvassa Municipal Council has notified vide notification No.SMC/CO/TVC -Election/2021/139/2035 dated 08 /06/2021 to elect new members for Town Vending Committee for amongst the street vendors of Silvassa Municipal Council jurisdiction as per Rule 13 of Union Territory of Dadra and Nagar Haveli Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015.

Whereas, as per Rule 12 of Union Territory of Dadra and Nagar Haveli Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015 and Schedule appended to Rule 14 of the same, the number of members to be elected including seats reserved are classified as under:-

- a) General : 02 Nos.
- b) Schedule Tribe : 01 No.
- c) Women (with due representation of the Scheduled Castes, Scheduled Tribes, Other Backward Classes, minorities and persons with disabilities) : 01 No.

Now, therefore, in pursuance of provisions of Rule 14 of Union Territory of Dadra and Nagar Haveli Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015 and Schedule appended to these Rules, Silvassa Municipal Council hereby notify the following dates for the said elections:-

Whereas, as per Schedule appended to these Rule 14 of Union Territory of Dadra and Nagar Haveli Street Vendors (Protection of Livelihood and Regulation of Street Vending) Rules, 2015,

- i) The candidate will deposit a security deposit of Rupees Two Thousand in cash or bank draft or pay order along with the nomination paper. On acquiring the less than one sixth of the Votes polled, the security deposits will be forfeited to the authority
- ii) The candidate will present the nomination in person himself or by his proposer or seconder to the Returning Officer.
- iii) A candidate will be at the liberty to withdraw his candidature by notice in writing signed by him & submitted in person at any time after the presentation of this nomination papers. but before 5.00 pm on the day following the day on which the valid nomination are published to the Returning Officer of the Town Vending Committee & a notice of withdrawal of candidature once given will be irrevocable.
- iv) Canvassing for votes by any person at the place where election is conducted will be prohibited.
